FIRST ROUND OF ADMISSION

List of the eligible candidates for admission to LL.M. Two Year Degree Programme for the academic year 2025-2026 is displayed on the Notice Board.

The candidate is required to collect the **Admission form** in Room No. 126, First Floor, Department of Law, University of Mumbai, Fort Campus, Mumbai – 400 032.

The candidate is required to submit (02) copies of Passport size photograph.

VERIFICATION OF DOCUMENTS

1. The candidates should fill up and Submit admission form in **Room No. 208, Second Floor**, Department of Law, University of Mumbai, Fort Campus, Mumbai – 400032, **from 9th October, 2025 to 13th October, 2025 as per verification schedule. (Lunch Break from 1.00 p.m. to 1.30 p.m.).**
2. LL.M. Admission is subject to verification of documents. In case of incomplete and false submission of documents the candidate is not eligible / entitled for admission.
3. The candidates are informed to bring all original relevant documents for verification and scrutiny. The scrutiny of documents will be done in Room No. 208.
4. Pre-Registration Form should be attached with the Admission form at the time of Verification of document.
5. After verification of documents, office will approve the LL.M. admission of candidate.
6. After approval of admission the Department of Law will provide details to the candidate for payment of Admission fees.
7. Admission Fees is to be paid online (NEFT/RTGS/UPI/QR Code).

Guidelines and Norms for LL.M. Admission 2025 – 26

- Candidates whose names appear in the list for first round of LL.M. admission should take their admission within the prescribed date as per the schedule given hereunder.
- Candidates whose Marksheets are in reserved/hold are required to get the stamp and signature of the concerned Principal on gazetted copy of the declared result.
- All candidates whose names appear in the list for first round of LL.M. admission at the University of Mumbai are hereby informed that if they are currently enrolled as LL.M. students at the University of Mumbai or any other University / College, it is mandatory for the candidate to cancel their previous admission within 5 days.
- If the candidate fails to comply with this requirement the candidate will not be eligible for subsequent admission.
- Those candidates who have been admitted as per preferences other than First preference shall be considered for admission to vacant seats in next round as per vacancy available in their respective category / quota.
- A candidate must confirm admission on allotted seat as per the schedule given hereunder.
- In scrutiny, if the candidate is found to be ineligible in the category/quota applied for admission, the candidate shall not be considered in the same or subsequent rounds of admission process.
- The preferences submitted by the candidates in the Google Form for LL.M. Admission 2025-26 cannot be altered or changed at any stage during the admission process.
- After completion of First round of LL.M. Admission process, the Department of Law shall notify the vacant seats of each respective group of LL.M.
- The Department of Law shall fill up subsequent vacant seats of respective group of the LL.M. based on the merit of the candidate.

At the time of filling of vacancies during final round of LL.M admission, if any seat belonging to any categories such as SC, ST, DT/NT, SBC, OBC, EWS, SEBC remains vacant then such seat shall be filled up as against other categories such as :

- Vacant ST category seats are to be allotted to SC category candidates & vice versa.
- Vacant DT/NT category seats are to be allotted to OBC category candidates & vice versa.
- Vacant EWS seats are to be allotted to GENERAL category candidates.
- Vacant SEBC seats are to be allotted to GENERAL category candidates.
- Vacant SBC seats are to be allotted to OBC category candidates & vice versa.
- Vacant Divyang (PWD) seats are to be allotted to GENERAL category candidates.
- Vacant Quota seats are to be allotted to GENERAL category candidates.
- Vacant Quota of Orphan candidate's seats are to be allotted to GENERAL category candidates.
- Vacant General Category seats are to be allotted to other General Category candidates.
- GENERAL category includes all other categories.

The above vacant seats shall be filled up as per the interchangeability norms of the Government and University of Mumbai. In any circumstances, if the seats remain vacant even after applying interchangeability norms, such vacant seats shall be allotted to the General Category.
